(NURSING), B.Pharm (LE), DIPLOMA IN CLINICAL ECHO CARDIOGRAPHY(DCEC), DIALYSIS TECHNOLOGY (DDT) & CLINICAL MICROBIOLOGY (DCM)** courses along with Information Bulletin (PG) 2016-17 can be downloaded from the Institute's website <http://mtihs.puducherry.gov.in> from **04.07.2016** (Monday) **onwards**. The downloaded application form should be filled up by the candidate in his / her own handwriting and duly signed by the candidate. No other form of application is permitted.

The candidates are advised to read the Information Bulletin (PG) 2016-17, before filling the application form and ensure that no column is left blank. In the event of rejection of the application form, no correspondence will be send. The status may be known from the institute website on publishing the merit list.

The **filled in Application form** with self-attested passport size photograph, pasted on the space provided, shall be considered with self-attested **copies of necessary certificates** and **Demand Draft** for application fee (Candidate shall write their name behind the DD) drawn from any Nationalised Bank, in favour of "**THE DEAN, MTPG& RIHS**" for application fee. Demand draft and other enclosures can be stapled / tagged together with the application form. They shall be send by post/courier or can be submitted in person to "**THE DEAN, Mother Theresa Post-Graduate & Research Institute Of Health Sciences, Indira Nagar, Gorimedu, Puducherry – 605 006**".

2. ELIGIBILITY FOR ADMISSION

2.1 MASTER OF SCIENCE IN NURSING - M.Sc. (Nursing)

ELIGIBILITY CRITERIA FOR ADMISSION:

- The candidate should be a Registered Nurse and Registered Midwife or equivalent with any State Nursing Registration Council.
- Minimum educational qualification shall be B.Sc. Nursing / B.Sc. Hons. Nursing / Post Basic B.Sc. Nursing with minimum of 55% aggregate marks. [50% for SC/ST]
- The candidate should have undergone in B.Sc. Nursing / B.Sc. Hons. Nursing / Post Basic B.Sc. Nursing on full time (regular stream; not distance mode) in an institution which is recognized by Indian Nursing Council.
- Minimum one year of work experience after Basic B.Sc. Nursing, as on 31.7.2016 (The experience will be calculated from the date registered with Nursing Council).
- Minimum one year of work experience prior or after Post Basic B.Sc. Nursing, as on 31.7.2016 (The experience will be calculated from the date registered with Nursing Council).
- The experience certificate should be from the competent authority (Medical Superintendent, Director, Resident Medical Officer, Manager, or similar cadres.)

2.2 MASTER OF PHARMACY – M.Pharm.

ELIGIBILITY CRITERIA FOR ADMISSION:

- Minimum educational qualification shall be B.Pharm. with minimum 55% of aggregate marks. [50% for SC/ST]
- The candidates applying for admission to M.Pharm course should have studied B.Pharm. in an institution approved by Pharmacy Council of India and All India Council for Technical Education.

2.3 MASTER OF PHYSIOTHERAPY – M.P.T.

ELIGIBILITY CRITERIA FOR ADMISSION:

- Minimum educational qualification shall be B.P.T. from a recognised university, on full time basis, with a duration of not less than 3 years of course of study and 6 months of compulsory rotatory internship. The minimum aggregate marks shall be 55%. [50% for SC/ST].

2.4 POST BASIC BACHELOR OF SCIENCE IN NURSING - P.B.B.Sc.(Nsg)

ELIGIBILITY CRITERIA FOR ADMISSION:

- Minimum educational qualification shall be Diploma in General Nursing & Midwifery with a duration of not less than **3** or **3½** years of course of study, recognised by the Indian Nursing Council. The minimum aggregate marks shall be 50%.
- Passed the Higher Secondary or an equivalent (10+2) examination recognized by the university for this purpose. Those who have done 11+1 in or before 1986, will be eligible for admission.
- The candidate should be a Registered Nurse and Registered Midwife or equivalent with any State Nursing Registration Council.

A male nurse, trained before the implementation of the new integrated course besides being registered as a nurse with State Nurses Registration Council, shall produce evidence of training approved by Indian Nursing Council for a similar duration in lieu of midwifery in any one of the following areas: O.T. Techniques, Ophthalmic Nursing, Leprosy Nursing, TB Nursing, Psychiatric Nursing, Neurological and Neuro surgical Nursing, Community Health Nursing, Cancer Nursing, Orthopedic Nursing.

2.5 BACHELOR OF PHARMACY (B.Pharm) – Lateral Entry

ELIGIBILITY CRITERIA FOR ADMISSION TO II YEAR B.PHARM. (Lateral Entry) :

- Minimum educational qualification shall be Diploma in Pharmacy of 2 years duration from an institution recognised by the Pharmacy Council of India, with minimum 50% aggregate marks.
- Candidate should have completed 500 hours of hospital training and registered in any State Pharmacy Councils.
- Passed the Higher Secondary or an equivalent (10+2) examination in **Academic Stream** with Physics, Chemistry and Biology/ Botany & Zoology / Mathematics / Computer Science (vocational stream and open schooling are NOT eligible).
- The upper age limit is 50 years as on 31st July 2016.

2.6 DIPLOMA IN CLINICAL ECHO CARDIOGRAPHY [D.C.E.C.]

2.7 DIPLOMA IN DIALYSIS TECHNOLOGY [D.D.T.]

2.8 DIPLOMA IN CLINICAL MICROBIOLOGY [D.C.M.]

ELIGIBILITY CRITERIA FOR ADMISSION TO THE ABOVE DIPLOMA COURSES:

- Minimum educational qualification is a Bachelor Degree in any biological sciences (Zoology, Botany/ Plant Science, Physics, Chemistry, Biotechnology, Biochemistry, Microbiology, Radiography, Nursing, Pharmacy, Physiotherapy, Medical Lab. Technology or its equivalent) from any recognised University.
- The minimum age should be 20 years as on 31st December, 2016; maximum age is 35 years as on 31st July 2016.

3. DETAILS OF RESERVATION & SPECIAL ALLOCATION

3.1 NATIONALITY:

A candidate seeking admission at MTPG&RIHS should be an Indian National. However, French Nationals residing in the U.T. of Puducherry and covered by the terms of the Treaty of Cession shall be treated on par with Indian Nationals, for the purpose of admission to all the courses.

3.2 DOMICILE CRITERIA FOR U.T. OF PUDUCHERRY:

A candidate is considered to belong to the UT of Puducherry, if he/she satisfies at least one of the following domicile criteria (Refer Annexure – I for the Format of Certificates):

- a) The candidates or whose parent (either mother or father or both) or Guardian (in the case of children who have lost both the parents) has been residing continuously in this Union territory for at least five years immediately preceding the date of application
- b) Those who have passed SSLC/HSC or any other public examination and for that purpose had undergone academic studies continuously for 5 successive classes immediately preceding the qualifying examination (including the year of the qualifying examination) in recognized education institutions (s) located in Puducherry Union Territory and having their residence in the Puducherry Union Territory for 5 years continuously during that period.
- c) Children of Central/State Government Servants/Defence Personnel /Central Paramilitary Forces/Employees of Public Sector Undertakings wholly or substantially run either by the Central Government or by the Puducherry UT administration posted and serving in the Puducherry UT for at least a minimum period of one year prior to the last date of submission of application.
- d) Children of Natives of UT of Puducherry who have declared any place in the UT of Puducherry as their home town (Father & Mother) and so certified by their respective Heads of Office. (Applicable only for Government employees).
- e) Children of Defence Personnel who were killed or disabled in action and children of Central Government Servants/Puducherry UT Government Servants/Defence Personnel/Employees of Public Sector undertaking as referred in category (c) who

died while in service in the Puducherry UT.

- f) French Nationals residing in the Puducherry UT and covered by the terms of the "Treaty of Cession" shall be treated on par with the candidates who produce the prescribed Puducherry UT residence certificate. Such French Nationals will not be required to produce residence certificate instead they should produce a certificate of registration issued for this purpose from the French Consulate at Puducherry.

Note: Children of these French Nationals shall not be considered for admission under the quota of non-residents.

3.3 RESERVATION:

Reservation to different category of candidates of Puducherry U.T. for admission to the Post-graduate courses is given below. Further SC/BT/EBC/MBC/BCM/OBC candidates are also eligible for selection under Open competition/General category in addition to the reservations made to them.

Candidates claiming admission under these categories should enclose the recent community / caste certificate issued by an Officer of the Department of Revenue and Disaster Management, not below the rank of Deputy Tahsildar.

3.4 DOMICILE STATUS FOR OTHER STATES / U.T.s:

Candidates from other States/ Union Territories shall be Indian Nationals. They should produce Nativity / Residence Certificate issued by the competent authority.

3.5 INSERVICE CANDIDATES:

The in-service candidates of MTPG & RIHS / Directorate of Health & Family Welfare Services, Government of Puducherry / JIPMER should produce **Study permission letter/ No objection certificate obtained from the Appointing authority**, in respect of the current academic year for consideration of the candidature.

The in-service candidates should send the application form along the necessary enclosures and Demand Draft, through proper channel so as to reach the office of the Dean before the last date for submission of application.

Note: If there exists any vacancy in the respective category of the in-service seats, it will be filled by the other institute in-service candidates. If there still exists any vacancies in the in-service seats, the non-service candidates will be considered for admission as per the merit marks.

4. SELECTION PROCEDURE FOR ADMISSION

4.1 MERIT LIST

4.1.1 M.Sc. (NURSING)

The selection of candidates will be based on the merit list drawn from the merit marks, giving 50% weightage to the aggregate marks obtained in the qualifying examination and 50% weightage to the MTIET (PG)-16 entrance examination marks.

4.1.2 M. PHARM

The selection of candidates shall be based on a valid **GPAT-16** (All India Test) percentile/score. In case of a tie in the GPAT score, the aggregate marks of the qualifying examination will be the criteria for ranking. The GPAT candidates need not appear for the MTIET (PG) entrance examination. For GPAT Qualified Candidates GPAT scholarship is not guaranteed by the institution.

When GPAT-16 qualified candidates are not available, admission will be given to non-GPAT candidates of respective category on merit. The selection of Non-GPAT candidates will be based on the merit list drawn from the merit marks, giving 50% weightage to the aggregate marks obtained in the qualifying examination and 50% weightage to the MTIET (PG)-16 entrance examination marks.

In case of grade points / CGPA, the conversion to percentage of marks has to be furnished from the concerned University only. If not, Pondicherry University CGPA conversion table will be used for converting the grade points / CGPA to percentage marks. The speciality selection will be by the choice of the candidates as per merit list.

4.1.3 M.P.T.

The selection of candidates will be based on the merit list drawn from the merit marks, giving 50% weightage to the aggregate marks obtained in the qualifying examination and 50% weightage to the MTIET(PG)-16 entrance examination marks.

4.1.4 P.B.B.Sc. (NURSING)

The selection of candidates will be based on the merit list drawn from the merit marks, i.e., the aggregate marks obtained in the qualifying examination (DGNM). The allotment of seats to in-service candidates will be based on the list from the Directorate of Health & Family Welfare Services (DH&FWS), Govt. of Puducherry / JIPMER.

If there exists any vacancy in the respective category of the in-service seats, it will be filled by the other institute in-service candidates. If there still exists any vacancies in the in-service seats, the non-service candidates will be considered for admission as per the merit marks.

4.1.5 B.Pharm (Lateral Entry)

The selection of candidates will be based on the merit list drawn from the aggregate marks obtained in the qualifying examination (D.Pharm.)

4.1.6 D.C.E.C. / D.D.T. / D.C.M.

The selection of candidates will be based on the merit list drawn from the marks obtained in the MTIET(Dip)-16 Entrance Examination conducted exclusively for these diploma courses.

Note: In case of tie in the merit marks, TIE BREAKING will in the following order:

I – Aggregate mark percentage in the qualifying examination.

II- Aggregate mark percentage in the final year examination.

III – Date of Birth: Seniority will be given preference.

4.2 COUNSELLING FOR ADMISSION:

The Counselling and Allotment of seats for the respective courses will be conducted at **Mother Theresa Post-Graduate & Research Institute of Health Sciences**, Indira Nagar, Gorimedu, Puducherry – 605006.

Candidates shall be called for main counselling as per their merit through **“Individual Call Letters”** with date, time and venue of counselling. The Institute shall not be responsible for any postal delay. Counselling will not be done in the absence of

the candidate. Candidates who do not attend the counselling on the specified date and time will have to forego the claim of admission. Candidates who do not attend the main counselling shall attend the subsequent counselling as per their merit, for the available vacant seats only.

The date and time for the first counseling will be published in the institute website, and individual call letters will be sent to the candidates. **“Individual call letters” will NOT be send for subsequent counselling, the same will be notified in institute’s website.**

4.3 VERIFICATION OF ORIGINAL CERTIFICATES:

Candidates called for counselling shall be required to submit all the **certificates in original** for verification at the time of counselling. Candidates who failed to produce the required certificate in original shall not be considered for admission. However, if a candidate has submitted the original Certificates to an Institution, where he/she has already been admitted, a letter / bonafide certificate to that effect issued by the Head of the Institution should be produced. In such cases only, the self-attested copies of certificates will be considered for verification, subject to production of all original certificates including Transfer Certificate within the time specified by the Admission Committee.

4.4 SUBMISSION OF ORIGINAL CERTIFICATES:

The original certificates submitted by the candidate during admission shall be returned only after completion of the Course. On discontinuation of the Course, the original Certificates will be returned as per the regulations of the Institute. Hence the candidates are advised to take enough number of photocopies of the Certificates before submitting the originals for verification during counselling.
